SBA List Candidate Fund Endorsement Criteria

The goal of the SBA List Candidate Fund is to increase the percentage of pro-life women in Congress and high public office. To accomplish this, we endorse select pro-life candidates. To be considered for endorsement, candidates must fulfill the following criteria:

- 1) Be a pro-life woman running for election to Congress or statewide office
- OR
- Be a pro-life man running for election to Congress or statewide office *against a pro-abortion woman*
- 2) Complete our candidate questionnaire
- 3) Be a viable candidate
- 4) Be interviewed by the SBA List
- 5) Earn the official approval of our Candidate Selection Committee
- 6) Candidate Endorsements are considered on a rolling basis. If you know of a candidate that we should consider and meets the above criteria, email Lindsay Matlock at lmatlock@sba-list.org.
